

SANDALS RESORTS FLYAWAY OFFICIAL SWEEPSTAKES RULES

Introduction

By entering into any Lorino Communications Limited Liability Company d/b/a Throwback Brands (hereafter referred to as “**Sponsor**” or “**Administrator**”) sponsored Sweepstakes, each participant (“**Participant**”) agrees to abide by these Official Sweepstakes Rules and the decisions of Sponsor, such decisions which are final and binding in all respects.

NO PURCHASE IS NECESSARY TO ENTER OR WIN. PURCHASE OF ANY PRODUCTS OR SERVICES DOES NOT ENHANCE CHANCES OF WINNING.

Eligibility

The Sweepstakes is open to individuals who are both 18 years of age or older and legal residents of the United States on the entry date may enter at the time of entry. Fill in all the required information. Sponsor will not consider incorrect, fraudulent, incomplete, late, or otherwise non-conforming entries or entries that are intended to annoy, abuse, threaten, or harass any person or entity in any way. Limit of one (1) entry per email. Any entrant using fraudulent means to participate in the Sweepstakes will be disqualified and may be guilty of violating applicable criminal laws. All entries, once provided, are Sponsor’s sole and exclusive property. Eligibility is at the exclusive discretion of Sponsor, and Sponsor shall be entitled to reject any entrant for any reason or no reason at all without having to provide an explanation. Sponsor reserves the right, in its sole discretion, to cancel, suspend, or terminate the Sponsor for any reason and without prior notice to any Participant. In such instance, Sponsor may, if and as appropriate, select a winner using reasonable means that are materially consistent with the Sweepstakes.

Provision of Materials and Information/Intellectual Property

By entering into the Sweepstakes, Participant represents and warrants as follows: (1) that it fully owns or has properly licensed whatever materials or information it submits hereunder in connection with the Sweepstakes and can make such submissions without violating any applicable law, agreement with any third-party, and/or third-party right of any kind (including without limitation any intellectual property, data protection, privacy, or publicity right); and (2) that any and all materials or information provided by it hereunder shall be true and correct in all respects. Furthermore, without limitation on anything set forth herein to the contrary, Sponsor shall have the irrevocable, transferable, and fully sublicensable right and license (but not the

Random Drawing; Prizes; Notifying Prize Winners

One random drawing will be conducted on or about September 30, 2024, from all entries received between September 23, 2024 and September 29, 2024, and then another random drawing will be conducted on or about October 7, 2024, from all entries received between September 30, 2024 through October 6, 2024. Sponsor to select one (1) winner from each drawing for up to a total of two (2) winners (each a "Winner"), subject to compliance and eligibility with these Sweepstake Rules. Odds of winning depend on the number of entries received.

Each potential Winner's name will be announced on-air after each drawing. Each Winner will be notified by email or telephone number provided in his or her sweepstakes entry and must sign and return Sponsor's Affidavit of Eligibility and Release within 30 days following the effective date of Sponsor's prize notification (the "Notification"). Failure to respond within the applicable time period will result in forfeiture of the Prize (as defined below) and Sponsor shall have the option to award the Prize to an alternate Winner. The return of the Notification or Prize as undeliverable may also result in disqualification and an alternate Winner may be selected. Airfare includes round-trip coach airfare valid to/from the nearest major U.S. gateway of the Winner to the selected or designated resort's airport. The tickets are valid for the Sandals Prize Package Redemption Period (as defined below). Flights will be on mutually approved dates. Estimated Retail Value of Each Sandals Prize Package:

- (i) Sandals Resorts Accommodations = **US\$2,994; and.**
- (ii) Airfare for two (2) adults = **US\$1,000 (capped at \$500 per person).**

EVEN IF APPLICABLE LAW PROVIDES OTHERWISE, GUEST AGREES THAT ANY ARBITRATION OR LAWSUIT AGAINST UNIQUE TRAVEL CORP WHATSOEVER SHALL BE LITIGATED BY GUEST INDIVIDUALLY AND NOT AS A MEMBER OF ANY CLASS OR AS PART OF A CLASS ACTION, AND GUEST EXPRESSLY AGREES TO WAIVE AUTHORITY TO ARBITRATE CLAIMS ON A CLASS ACTION BASIS. THE VALIDITY AND EFFECT OF THIS CLASS ACTION WAIVER MAY BE DETERMINED ONLY BY A JUDGE OR COURT OF LAW. GUEST AGREES THAT THIS SECTION SHALL NOT BE SEVERABLE UNDER ANY CIRCUMSTANCES FROM THE FORUM SELECTION AND CHOICE OF LAW PROVISION SET FORTH IN THE UNIQUE TRAVEL CORP. – TERMS AND CONDITIONS. GUEST AGREES THAT THE PARTIES REFERENCED IN FOREIGN SELECTION AND CHOICE OF LAW PROVISIONS OF THE UNIQUE TRAVEL CORP. – TERMS AND CONDITIONS THAT MAY BE THE SUBJECT OF ANY CLAIM BY GUEST CAN RECEIVE IMMEDIATE JUDICIAL ASSISTANCE TO ENFORCE THIS CLASS ACTION WAIVER.

THE PARTIES HERETO ACKNOWLEDGE AND AGREE AS FOLLOWS: (1) THAT ALL DISPUTES, CAUSES OF ACTION, AND CLAIMS CONNECTED TO OR ARISING IN ANY WAY HEREUNDER BETWEEN THE PARTIES SHALL BE RESOLVED SOLELY ON AN INDIVIDUAL BASIS (I.E., CLASS ACTIONS SUITS ARE HEREBY WAIVED BY THE PARTIES), AND EXCLUSIVELY BY THE STATE OR FEDERAL COURTS SITUATED IN WISCONSIN; (2) THAT THE LAWS OF THE STATE OF WISCONSIN SHALL GOVERN, WITHOUT REGARD TO ITS CONFLICT OF LAWS PRINCIPLES; AND (3) THAT THE PARTIES HERETO WAIVE ANY RIGHT TO A TRIAL BY JURY.
